





# . STANGER HALL




To answer the demands and expectations of the computer era, Stonehill will break ground in August for the construction of Stanger Hall, which will comprise the Lockary Computer Laboratory. The new facility will be located on the main quadrangle on the lower campus, facing the Cushing-Martin Library.

The \$2,000,000 building will consist of 17,000 square feet to house a central computer facility, one hundred workstations, classrooms, conference and seminar rooms, a computer library, faculty office space, and increased software storage space.

The building itself is named after John W. Stanger, Vice Chairman of General Electric Credit Corporation. He received an honorary doctor of business degree from Stonehill in September, 1984, in recognition of his commitment to private higher education.

The Lockary Computer Laboratory is named after Rev. Thomas Lockary, C.S.C., a professor of physics and mathematics for the past thirty years. Since 1979, Fr. Lockary has pioneered the growth of computer studies at the College.

# Dan Rostenkowski: 1985 Commencement Speaker

Addressing an audience of over 450 graduates, their family and friends, Congressman Dan Rostenkowski emphasized the value of a Catholic education as one "that's based on balance." He continued, "You may have been fed the facts, but you've also learned that they have a moral component ... it's the combination of the two that is important."

Congressman Dan Rostenkowski, Chairman of the House Ways and Means Committee, has represented the 8th Congressional District in Illinois since 1958. In addition to this influential congressional position, he chairs the Joint Committee on Taxation. Congressman Rostenkowski also received an honorary Doctor of Laws degree at the ceremonies.

Also awarded honorary degrees this year were Fritz Eichenberg (Doctor of Arts), noted illustrator; Dr. Brunetta R. Wolfman (Doctor of Letters), President of Roxbury Community College; and Barbara A. Rockett, M.D. (Doctor of Humanities), President of the Massachusetts Medical Society.

In addition to the four honorary degrees, Stonehill's Benaglia Award was presented to Rev. Thomas E. Lockary, C.S.C. A professor of physics and mathematics for the past 30 years, the award is in recognition of his distinguished contributions and dedication to the College.

# Bruce Thorne '73 Dies Awaiting Heart-Lung Transplant

Family and friends of Bruce Thorne '73 lost the battle to save his life November 17, 1984. Bruce was afflicted with interstitial fibrosis, a rare genetic lung disease that restricts breathing and damages the heart. A heart-lung transplant provided the only hope to save his life.

A resident of Hanson, Massachusetts, Bruce and his wife, Joan, travelled to California to undergo tests at the Stanford Medical Center to determine his chances for a successful heart and lung transplant. Upon receiving notification of his eligibility for the transplant, Bruce and his wife located temporary housing near the medical center. Bruce died while waiting for the organ transplants.

A trust fund, spearheaded by Malcolm Nordley '73 and several of Bruce's Stonehill classmates, was established at the Quincy Cooperative Bank. Fund-raising efforts collected more than \$20,000 to help pay the cost of the transplant operation, as well as the family's expenses.

A native of Dedham, Bruce was a branch manager for SGS Control Services, Inc., in Chelsea. He also leaves a three-year-old son, Michael.

# Rita Smith '62 Named TIME Magazine's Teacher of the Year

An educator in the Brockton Public School System for more than 20 years, Rita E. Smith has been named Outstanding Social Studies Teacher of the Year by TIME magazine and the National Council for Social Studies.

Rita, a Class of 1962 graduate, teaches "Shaping of Western Society" to 144 tenth-graders. With her imaginative teaching methods, she injects vitality into the disciplines of art, reading, music, writing and history.

Although a ''traditional'' teacher, Rita's student projects are spectacular and unconventional. There is a giant map of Europe painted by students on the floor of her classroom. On the ceiling above, another class of students has painted a map of the solar system that glows florescently in black light. Annually, her class participates in a ''living' chess game whereby students play chess pieces while costumed as historical characters. Rita's educational philosophy involves this use of outrageous imaginative projects to shock students out of cynicism and into participation.

In addition to the Teacher of the Year Award, Rita was one of 20 people nationwide to receive a Fullbright-Hayes Scholarship enabling her to travel to China for six weeks. A frequent traveler abroad, she has also delivered talks before educational groups in Holland and Italy.

Stonehill will join TIME magazine and the National Council for Social Studies in honoring Rita E. Smith by awarding her the 1985 Outstanding Alumnus Award. Plans are currently underway for the presentation ceremony slated for later this year.



## Stonehill Tuition Increase: 7.0%

At the January meeting of the Board of Trustees, approval was granted for a 7.0% increase in tuition and a 5.0% increase in room and board charges.


For the 1985-86 academic year, tuition stands at \$5,900 with room and board expenses at \$3,150, for a total of \$9,050. Tuition in the evening division will increase by 7.5%, from \$265 to \$285.

The Trustees and Administrators of the College are committed to maintaining tuition costs as low as possible. Due in large part to this commitment, the tuition figure for Stonehill is noticeably below that of area colleges and universities. In addition, the percentage of increase for the upcoming academic year is among the lowest of these area institutions.

For the purpose of comparison, the following chart highlights Stonehill's favorable standing in terms of tuition charges:

# Prof. Phelan Publishes Novel



Professor Francis Phelan has published his first novel, FOUR WAYS OF COMPUTING MID-NIGHT, in which he narrates his calling to the priesthood and his ultimate decision to leave the vocation. A profound tale of moral choices, *Kirkus Reviews* described the book as

"precise, vivid, and sometimes bitterly amusing."

Born in Pittsburgh and raised in a country preparing for war, Prof. Phelan prepared himself for the seminary at the University of Notre Dame. The novel follows him into the cloister where he takes instruction in the spiritual life and liturgy, yet still he wrestles with the moral questions of war as word of the Holocaust penetrates the seminary walls. At last ordained in 1954, the years of certainties fade and doubts arise. He left the priesthood by the mid-70's.

Prof. Phelan's short story of the same title received the 1982 Pushcart Prize. His fiction has appeared in *The Georgia Review, The Southern Review, The Windsor Review,* and *The New Yorker*. Recently promoted to the rank of full professor at Stonehill, he is at work on a second novel.

### New Trustees Elected

The Board of Fellows selected five new trustees at their March 4, 1985 meeting. Elected were Sol Gittleman, Ann L. Hagan, Albert Lippert, Rev. Laurence Olszewski, C.S.C., and Rev. Patrick Sullivan, C.S.C.

Sol Gittleman is Academic Vice-President/Provost at Tufts University in Medford, Mass. A professor at the University since 1964, Dr. Gittleman served a 15-year term as Chairman of the Department of German-Russian. His expertise is in the area of comparative literature.

Ann L. Hagan, a 1965 Stonehill graduate, is Managing Director of Capital Markets Group, Merrill Lynch & Company in New York City. The 1983 recipient of the Outstanding Alumnus Award, Ann is one of the highest ranking women on Wall Street in municipal utilities in terms of client and revenue production.

Albert Lippert serves as Chairman of the Board of Weight Watchers International, Inc. A resident of Long Island, New York, Mr. Lippert has been associated with Weight Watchers for 24 years, directing the worldwide services of the corporation.

Rev. Laurence Olszewski, C.S.C. is the National Coordinator of Church Affairs for Catholic Relief Services, U.S.C.C. He also serves as the Director of Education and Director of Planned Giving at Catholic Relief Services. Fr. Olszewski is a Stonehill graduate from the Class of 1961, and worked as Director of Career Placement at the College from 1973 to 1976.

Rev. Patrick Sullivan, C.S.C., serves as an adjunct assistant professor in Sociology at the University of Notre Dame. Fr. Sullivan has enjoyed a long and distinguished career as administrator, educator and social activist.

# Dr. George Hagerty '75 Appointed Director of Academic Development

Dr. George Hagerty, former Chief of Program Administration for the United States Department of Education, has been appointed Director of Academic Development at the College.

A Class of 1975 graduate, George returns to Stonehill with an M.A. and D.Ed. from Harvard University in Administration, Planning and Social Policy. Following a year as Post Doctoral Fellow at the University of Maryland, George worked for the Department of Education in several capacities.

Serving as the College's first Director of Academic Development, George's primary responsibilities are to encourage and assist faculty members in acquiring funds to support their continued development as instructors and scholars and to improve academic curriculum. With the rank of associate professor, he will also teach on a limited basis.

This recent appointment was announced by President Bartley MacPhaidin, C.S.C., in response to faculty requests for a development professional to serve their funding needs.




#### **New Dorm Constructed**

In response to the increasing demand for on-campus residency and recent dormitory overcrowding conditions, the College has constructed a new housing facility — Cascino Hall. Construction work on the 51-bed student residence was completed in only five months and was occupied at the start of second semester in January.

Cascino Hall is similar in architectural design to Sullivan Hall and stands adjacent to it. The facility consists of five suites, one resident advisor's room, and additional areas for recreational, laundry and storage needs.

The building is named after Anthony E. Cascino, former Vice Chairman of the Board at International Minerals & Chemical Corporation. Mr. Cascino currently serves as Chairman of the Stonehill Board of Advisers.




